



**PROMISES TO STREAK** 2022 Breeding Fee - \$1,250.00

**SEMEN REQUESTS:** Outlaw Equine (940) 626- 8387

This **STALLION BREEDING CONTRACT**, is made and entered into by and between **Southwestern Farms**, hereinafter designated breeder, and \_\_\_\_\_, hereinafter designated Mare Owner. Mare Owner agrees to breed the mare \_\_\_\_\_, Reg. No. \_\_\_\_\_, to Promises to Streak, for a live foal, subject to the following conditions.

- 1) The stallion fee includes a non-refundable booking fee of **\$500.00**, payable with this contract. The remaining **\$750.00** of the breeding fee along with collection and shipping fees must be paid in full **before** semen is shipped. If balance is not paid and semen is not shipped, Mare Owner will forfeit booking fee and this contract will become null and void. Should more than one embryo result from breeding, mare owner will pay an additional stud fee.
- 2) **Please return a copy of the mares' registration papers along with the booking fee. The owner recorded on the registration certificate will be recorded on the stallion breeding report.**
- 3) Breeder requires notification from Mare Owner the day before semen is needed, and confirmation by 9 AM CST the day of. Semen orders not cancelled by 9 AM CST on collection days will be subject to cancellation fees. In the unlikely event of insufficient semen on a particular breeding day, Breeder reserves the right to determine which mares will be bred, based on reproductive status and early notification.
- 4) Collection and shipping dates for Breeder are Monday, Wednesday, and Friday. Counter to counter shipments are not available. All semen is shipped through FedEx, and all shipping/ collection charges will be paid to Outlaw Equine directly. Semen shipments may be picked up at Outlaw Equine, but will be charged a packaging fee of \$50.
- 5) Mare shall be checked to be in healthy and sound breeding condition by a veterinarian. Any previous breeding problems shall be disclosed to Breeder. Breeder agrees to diligently try to settle mare; however, if mare fails to settle for any reason, Mare owner will hold Breeder blameless. Mare Owner is required to have mare ultra-sounded by a licensed veterinarian 14-16 days after being bred and said results shall be sent/phoned to Breeder. Any mare not ultra-sounded 14-16 days after being bred will make the "Live Foal Guarantee" null and void.
- 6) This contract contains a "Live Foal Guarantee". A live foal is described as a newborn foal which stands and nurses without assistance. If foal is born dead, there are return privileges for the following season only if Breeder is notified within 7 days and receives a veterinarian's statement confirming death. If mare does not check in foal or if after being pronounced "safe in foal", the mare should miscarry, abort or prove barren, Mare Owner has the privilege of a return breeding during the current breeding season or the following year. Mare Owner will be responsible for collection fee and shipping fee on all rebreeds.
- 7) A "Breeders Certificate" will be issued for the foal conceived by this mating when stallion fee and all other expenses have been paid in full; and, when Breeder has been notified by Mare Owner that the mare has produced a live foal by this mating.
- 8) It is further agreed that should the stallion die, be sold by the owner, or become unfit for service prior to settling the mare; that the breeding fee not including the booking fee will be refunded to the Mare Owner. If the mare dies or becomes unfit to breed before pronounced safe in foal, the Breeder will accept another mare upon approval.
- 9) This Contract is nonassignable and nontransferable. This Contract is entered into in the State of Texas and will be interpreted and enforced under the laws of that state. This Contract represents the entire agreement between parties. No other agreements or promises, verbal or implied, are included unless specifically stated in this written Contract. When Mare Owner and Breeder sign this Contract, it will then be binding on both parties.
